## DOGS ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. **Condition of the Dog.** Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

## MOVE-UPS

All pre-trial move-ups must be received by 5pm, Monday July 6, 2026. AKC requires move-ups to be in writing. You may send an email for a move-up to Donette Belknap at [agilitydogs6@outlook.com](mailto:agilitydogs6@outlook.com) with your name, your dog's call name and what class you want the dog moved from and moved to. There will be no move-ups in the morning before the start of the trials.

Move-ups between trials will be offered. Move-ups must be received in writing no later than 30 minutes after the conclusion of the class/element you earned your title.

## ENTRY FEES

No entries will be accepted by phone, email, or fax. Express mail entries must include the signature waiver allowing them to be left at the secretary's address. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

**Illegible entries** will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

## WAIT LIST INFORMATION

Roaring Fork Kennel Club is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 25 entries will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to June 24, 2026 6:00pm MDT. No entries may be withdrawn with a refund after closing of waitlist on June 24, 2026 6:00pm MDT, unless replaced by a waitlisted entry. If a withdrawn entry is replaced by a wait listed entry, full refund will be issued for the withdrawn entry. **Any wait listed entry that does not move off the wait list by June 30, 2026 5:00pm MDT and into the trial will receive a full refund of waitlisted runs only.** If you are wait listed and choose not to accept a partial entry, you must pull your entire entry before the closing date.

## STAGING AREA, HANDLERS' BRIEFING, AND WARM-UP INFORMATION

**Staging Area** will be out of view of search area(s). Staging area will include crating, warm-up and waiting area, as well as the secretary table for check-ins and posting of running order and results.

The **Handler's Briefing** will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing the judge will explain if there's an off-leash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler's Briefing. There will be separate briefings and walk throughs for each level.

A **warm-up area** the club shall designate a warm-up area. One labelled container per target odor being used in the trial on that day will be placed in the warm-up area. This will allow handler-

dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well. Clubs may also place blank containers.

**SEARCH AREA AND RING CONDITIONS**

Search areas may be of any shape, and of the size specified in the Regulations for each class.

**Search Area Conditions.** Searches may be indoors, on matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

**Search Area Sizes** will be as required in the *Regulations for AKC Scent Work*.

**ADDITIONAL SITE INFORMATION**

**Trial Site.** It is not appropriate to visit the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future.

**Entrance Area.** AKC does not allow Clubs to make special accommodations for certain dogs (such as dogs determined by their owners to be “reactive”). The entrance point to the trial and to the search areas will be very busy and not conducive to extremely reactive dogs. We are not able to change the environment for specific dogs. Expect dogs in line for search areas, in addition to dogs exiting through the staging areas.

**Guns, Weapons & Illegal Drugs.** No Guns, weapons or illegal drugs are allowed on the show grounds.

**Possession of Odors and Training.** Chapter 5. Section 26 of the Scent Work Regulations state “No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area.”

**Spectator Area.** Spectators are encouraged. Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. No one outside the search area may assist the handler or disclose the location of the hide.

**Crating space** will be in the large animal barn. Roaring Fork Kennel Club and Douglas County Fairgrounds will not be responsible for any lost or damaged items.

**Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

## RIBBONS, AWARDS, AND PRIZES

Placement ribbons will be awarded in each class as follows:

<i>First Place</i> .....	<i>Blue</i>
<i>Second Place</i> .....	<i>Red</i>

New element title & level ribbons will be awarded to dogs finishing a title.

Ribbons will be self-serve. All ribbons must be picked up by the end of the trial. No ribbons will be mailed.

## High In Trial

Only teams who participate in the same difficulty level in all elements offered (Container, Interior, Exterior, Buried, and qualify in each are eligible to win **High in Trial**. One High in Trial winner is chosen per difficulty level; there is no separate High in Trial for the Novice A and Novice B sections. The High in Trial is determined by adding the team’s faults across the elements. If there is a tie based on faults, then the team’s times across the elements will be summed and the faster-finishing team will win. The High in Trial award is not recorded by the AKC Teams winning High in Trial will earn a rosette.

## NOTICE TO EXHIBITORS

### SAFETY, BEHAVIOR and LIABILITY

**The safety of the dog** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Kennel Club, Roaring Fork Kennel Club, Douglas County Fairgrounds and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. Roaring Fork Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against or any official thereof.

**Collars, Leashes and Harnesses.** During searches, dogs must wear a properly fitted collar or harness approved by the judge and in accordance with the AKC scent work regulations. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

**All dogs must be on leash** at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

### ENTRY REFUNDS

**No entry fee** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee or Roaring Fork Kennel Club. **No entry fee** will be refunded in the event of errors, entering the same dog twice, cancellation of entries after the published time of closing; nor in the event that a dog is absent, disqualified, excused the Veterinarian or Judge or barred from competition by the trial/show committee.

**Bitches in season** will be refunded the full entry fee. Notification in writing, from a veterinarian, must be given to the trial secretary no later than one half hour prior to the start of the trial.

### RINGSIDE

**Judges are not required** to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

### ADDITIONAL

**Food Vendors** There may be food vendors on-site. There are also fast food and restaurants in town.

**RV & Overnight Parking** will be available. See RV Reservation and RV Parking in Roaring Fork Kennel Club Premium (link below).

**Food Vendor Truck** will be stationed Friday, Saturday and Sunday between the Pavilion and Multipurpose Building near the Scent Work grounds.

**EXHIBITOR CHECK-IN:** At check-in you will receive your armband number. Further information will be including in the judging program and emailed to all exhibitors.

**Exhibitors MUST check-in Each day they are entered.**

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. I (we) agree that the determination of whether the injury is serious shall be made by the event veterinarian and is binding on me (us). HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS, AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.
